HCPSS Family Emergency File Form - Please Complete

If you have not completed the Family Emergency File Form, we are asking you to make that a priority. The Family Emergency Form must be completed each school year. Even if your child's emergency contact is the same as last year, we need you to go into your child's account and either update or confirm his/her emergency information. Thank you to the families who have already updated/confirmed their child's emergency contact information in Family File.

Login to HCPSS Connect and select the Family File tab to review and, if needed, update your child's emergency contact, medical, arrival/departure information, and your preferences regarding data confidentiality.

User guides for HCPSS Connect account activation and password reset, as well as Family File can be found in Guides.

NOTE: You must have a valid HCPSS Connect username and password to access the Family File.

If parents/guardians forget their passwords, they can have HCPSS Connect email them a temporary password.

- I. On the HCPSS Connect website, click the HCPSS Connect Login button.
- 2. Click the Parent/Guardian Forgot Password link.
- 3. Enter the email address used at the time of registration.
- 4. Click the Send Email button.
- 5. The parent/guardian will receive an email with a temporary password and a link to login.
- 6. The parent/guardian will click on that link and use the email address used at the time of registration and the temporary email to gain access.

Tips for School Success - Attendance

Good attendance benefits your child's education. Students who miss a day of school not only miss instruction but also must make up work and catch up with the new material at the same time. Try to schedule doctor and dentist appointments on early release days, school holidays, or at the beginning or end of the school day to limit missed instruction. If you learn there are reasons why your child does not want to come to school, please contact your school counselor so that the underlying issue can be addressed.

Policy Corner

HCPSS policies will be shared with students, parents, and staff through various forms of communication such as TVMS newsletters, announcements, and printed handouts. For a full review of policies, please refer to pages 23 through 30 in the Middle School Student Code of Conduct and Related Policies packet or the *Student and Parent Handbook 2016-17*, which were sent home with your youngest or only student on Monday, August 29th. You may also choose to click on the Handbook link on the HCPSS website.

Policy 9230, Alcohol, Other Drugs, Prescription Medication and Over the Counter Products, is highlighted in this newsletter.

The possession, use, or distribution of alcoholic beverages and other drugs on school premises or at school-related or school-sponsored activities is prohibited. Prescription medication and over-the-counter products require written medication orders and are to be administered in accordance with school system Health Services procedures. Legal searches and seizures related to this policy may be conducted on school property. Confidentiality is guaranteed for students who seek counseling for drug or alcohol abuse problems.

For a first offense, a student found using or in possession of alcoholic beverages or other drugs will be suspended from school for not more than 30 school days and will be suspended from attendance at, participation in, and practice for, all extracurricular and school activities for 30 school days. Exclusion from commencement exercises is only applicable if it occurs during the suspension from school. The student will be referred for mandatory counseling in a licensed addictions program.

A second offense results in a suspension of up to 45 school days and suspension from attendance at, participation in, and practice for all extracurricular activities for the remainder of the current semester and the next consecutive semester. Exclusion from commencement exercises is only applicable if it occurs during the suspension from school. The student will be referred for mandatory counseling in a licensed addictions program.

A third violation results in expulsion.

Possession or use of prescription medication or over-the-counter products in the absence of, or inconsistent with, a written medication order, will result in a suspension of not more than 30 school days for a first offense. A school administrator may consider a lesser consequence than suspension under certain circumstances.

A second offense may result in suspension from school for not more than 30 school days and from attendance at, participation in, and the practice for, all extracurricular and school-related activities for 30 school days. The student may be referred for mandatory counseling in a licensed addictions program. A lesser consequence can be considered based on the consequence for the first offense.

A third offense may result in a suspension of not more than 45 school days and suspension from attendance at, participation in, and practice for all extracurricular and school-related activities for the remainder of the current semester and the next consecutive semester. The student may be referred for mandatory counseling in a licensed addictions program. Consequences for a third offense are also dependent on the consequences assigned for the first two offenses.

Students who distribute or intend to distribute alcohol or other drugs on school property will be suspended from school for not more than 45 school days or expelled. If suspended, the student also will be suspended from attendance at, participation in, and practice for all extracurricular and school-related activities for the remainder of the semester and the next consecutive semester. The student will be referred for mandatory counseling in a licensed addictions program.

A second violation results in expulsion.

A school administrator may consider a lesser consequence than suspension if the student distributes an over-the-counter product that can be clearly identified. If this condition is not met, the administrator will suspend the student for not more than 45 school days.

A second offense results in a suspension for not more than 45 school days and suspension from attendance at, participation in, and practice for all extracurricular and school-related activities for the remainder of the semester and the next consecutive semester. The student will be referred for mandatory counseling in a licensed addictions program.

Subsequent violations will result in suspension of not less than 45 school days or expulsion. If suspended, the student also will be suspended from attendance at, participation in, and practice for all extracurricular and school-related activities for the remainder of the semester and the next consecutive semester. The student will be referred for mandatory counseling in a licensed addictions program.
